2. A credit assessment will be conducted by our credit department before approval to sign up.

##### Rental Period:

1. The rental period shall be a minimum of 12 months.

##### Rental Payment

1. The rental payment shall be paid monthly through a direct debit mechanism only.

##### Security Deposit:

1. A security deposit will be required before the delivery of each contract. The security deposit amount shall be agreed upon at the time of the rental agreement and shall be refunded upon the satisfactory return of each contract, subject to any deductions for any damages, late fees or other amounts owed to the rental company.

##### Use of the Laptop:

1. Each unit shall be used solely for its intended purpose and in accordance with all applicable laws, rules, regulations, and guidelines. The rental customer shall be solely responsible for any damage, loss, or liability arising from the rental customer's use of each unit during the rental period.

##### Logistics (Transportation, Deployment, Dismantle & Collection)

1. Logistic coverage is limited to the Klang Valley area only. A minimum charge will be applied if services are required outside Klang Valley.

##### Maintenance and Repair:

1. The rental company shall be responsible for the scheduled preventive maintenance schedule preventative maintenance and corrective maintenance of the unit during the rental period.
2. If the rental customer experiences any issues with the unit during the rental period, the rental customer shall notify the rental company promptly.
3. The rental company shall be responsible for the repair or replacement of the unit if any damage occurs as a result of normal use during the rental period, at no additional cost to the rental customer.
4. The rental company shall not be responsible for any loss or damage to any data or software stored on the unit.

2. Early Termination Fee: You are required to pay the remaining balance from the contract not billed.

1. The rental company shall not be liable to the rental customer for any loss of profits, revenue, or goodwill, or any indirect, special, consequential, or incidental damages arising out of or in connection with the rental of each unit.


##### Governing Law

1. The rental agreement shall be governed by and construed in accordance with the laws of the jurisdiction where the rental company is located.
